पारसिक कचराप्रश्नी रेल्वेची बघ्याची भूमिका

मुंबई उपनगरीय रेल्वेकडून कचरा टाकण्यास पाच इजागारांचा दंड घडत करण्याच्या कारवाईची घोषणा भंडारवाडीमध्ये मध्य रेल्वे सुरुक्षा दलाचे (आरपीएफ) केली होती. पाच महिन्यांनंतरही याची अंमलबजावणी रूढली आहे. पारसिक बोगद्यावरील अनाधिकृत झोपड्यांमधून रेल्वेकडून कचरा टाकण्यात येत असल्याची तक्रार केल्या जाणाऱ्या कचराप्रश्नी रेल्वेने केवळ बघ्याची भूमिका घेतली आहे. मुंबई रेल्वे कडून विरोध पारसिक बोगद्यांवर हजारांच्या संख्येत अनधिकृत झोपड्या आहेत. झोपड्यांमधील सांडपाणी कचराची
