Last year, RattanIndia had restructured the debt offs 13.50 MW thermal plant in Amravati in Maharashira after roping in

in Maharashtra after roping in Goldman Sachs and Varde Partcontinual sactis and varue Part-ners, which came on board as equity investors taking over ₹4,050 crore debt from existing lenders, who had pumped in ₹6,574 crore into the project. Commissioned in June 2017, the 1,350-MW Sinnar plant,

with a debt of around ₹7,000 crore, has five units of 270 MW each.Theplanthasbeen shut for the past two years. The manage-ment is keen to restart at least two units to meet the PPA.
